Listing Fees - A listing fee of \$8.56 must accompany the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form

U.S. Exhibitors - To pay in Canadian funds, use Postal Money Orders or the equivalent made out in Canadian dollars. Personally discounted cheques will not be honoured. Please do not mark personal cheques "Payable in Canadian funds" or "At par" as such items are not readily cleared through the banks. THANK YOU.

Judging Order - UTD, followed by TD. Bitches in season will be allowed to compete and will run last (if T.D., last of T.D. test; if U.T.D., last of U.T.D. test).

Pinch or prong collars are not allowed on the Test grounds.

Drawing for tracks for the UTD will take place at 7:30am at the rendez-vous location: National Research Council (South Campus), Bldg M-58 Parking Lot, Mackenzie Drive, Ottawa, Ont

Drawing for tracks for the TD will take place at the completion of the UTD tests, but in no case sooner than 10:30 a.m., at the rendez-vous location: Tim Horton's, corner of Trim Rd and Watters Rd, Orleans, Ont

A no host lunch will follow.

Confirmation of entry and directions to rendezvous points will be forwarded to each competitor upon receipt of entry.

Alternates - As of 1991, the C.K.C. has ruled that all Tracking Tests, having a limited entry, must accept alternates to their entry list. Entrants will be informed of their position on the alternate list immediately following the closing date of entries and will be informed of a cancellation up to 1 hour prior to the Test.

Refunds – Entry fees for cancellations made before the closing date, and entry fees for dogs NOT entered in the Test, including alternates that did not receive or accept tracks, will be refunded within 18 days of the tracking test. Refunds will not be given to those who have tracks and withdraw after the closing date.

Entries will be accepted from Canada Post or from couriers. ONE entry per envelope. ABSOLUTELY NO EXCEPTIONS.

List of Trophies

All exhibitors receiving a "pass" will be awarded a ribbon.

Any successful entrant who has taken a tracking class at Best Friends School of Dog Training will receive an award.

ENTRIES CLOSE 9 P.M. Friday, September 11th, 2008, OR WHEN LIMIT IS REACHED.

Discipline Regulation: Neither the judge, club official, volunteer, nor any participant at this event shall be subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the C.K.C. any infringement. The Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
